

PROCEDURE FOR OBTAINING A LIFETIME LICENSE

- (1) DOG OWNER (a) This form is a Lifetime Dog Application. Application must be completed and signed by the dog owner. (If you are applying for a spayed female or a neutered male license you must send a copy of the Veterinarian Certificate).
 (b) The application may be submitted by mail or in person. When you submit your application to the County Treasurer, you must pay for your license before we can issue a lifetime number.
- (2) TREASURER (a) We assign your dog a lifetime number; we also fill out your Tattoo Certificate. We then mail your Tattoo Certificate back with your new lifetime number. You then have 30 days to have your dog tattooed. **YOUR DOG IS NOT LEGALLY LICENSED UNTIL THE ENTIRE PROCEDURE IS COMPLETED.**
- (3) DOG OWNER (a) You then take the Tattoo Certificate to a Tattooist or a Veterinarian. They in turn tattoo the lifetime number on the **RIGHT HIND LEG, ON THE INNER PART OF THE UPPER THIGH**. They must also complete the tattoo certificate; this will verify that the procedure is completed.
 (b) You mail the tattoo certificate into the County Treasurer's Office and await your metal lifetime tag. If this tag is misplaced, you must purchase a replacement tag for \$6.00 at the County Treasurer's Office.
 (c) When you receive your receipt and tag, your dog is legally licensed in the State of Pennsylvania. This license is not transferable from dog to dog. If you change your address or phone number in the future, please contact us by phone or by mail.

LIFETIME DOG LICENSE APPLICATION – YEAR of Licensure _____

A certificate attesting to the tattoo-licensed number issued by the COUNTY TREASURER must be completed by the dog owner and tattooist before the license will be issued.
