



Hempfield Township has a new Trash & Recycling hauler, **County Hauling**.

Through a competitive bidding process, **County Hauling** was awarded the contract for residential Trash and Recycling collection in Hempfield Township beginning January 1st, 2021. County Hauling was the lowest bidder for this service.

Guidelines for residential Trash and Recycling collection in Hempfield:

1. Your collection day for Trash and Recycling should remain the same. Some changes may occur during the transition.
2. Trash and recycling must be out the night before your collection day, or prior to 6 AM on the day of collection
3. Please bag all trash. Loose trash is a potential health hazard for our employees. If you are placing loose cardboard out for recycling, please flatten all boxes and stack them neatly next to your recycling can.
4. Yard Waste will be collected on your regular collection day along with your trash. Please bag all loose yard waste in biodegradable bags and cut and bundle any limbs or branches into bundles four feet long or less.
5. Each residence is allowed one bulk item per week (stove, washer or dryer, refrigerator/window AC unit with the freon removed, couch, etc.)
6. If you have more than one bulk item, or more than 15 bags of trash, please call Customer Service to schedule a collection. Extra fees may apply.
7. There will be 12 Leaf collections throughout the year. They will be advertised when the dates are finalized in the new year.

Senior Sticker Exchange Program

Hempfield Township will exchange **FULL SHEETS** of Senior Stickers from Advanced Disposal beginning Monday, January 4, 2021 at the Hempfield Township Municipal Building.

The senior sticker exchange program will occur between 8:00am and 4:00pm at the Hempfield Township Municipal Building located at 1132 Woodward Drive, Greensburg, PA 15601. This program only applies to **full sheets** of Senior Stickers from Advanced Disposal.

Hempfield Township will exchange stickers through January 29, 2021. The sticker exchange is in-person only, mail-in stickers will not be exchanged.

To purchase new stickers, contact County Hauling at 724-929-7694. Senior Stickers are \$3.00 each, minimum purchase of 12 stickers applies. Recycling is collected weekly free of charge.

Billing Account Information

We are pleased to inform you that County Hauling, a Noble Environmental company, was awarded the contract for residential Trash and Recycling collection in Hempfield Township beginning January 1st, 2021. We look forward to providing Hempfield with a safe and efficient collection program! Our contract is similar to the one that the Township had with your previous hauler and, expect in a few circumstances, your collection day for Trash and Recycling will remain the same.

The following guidelines apply to all residential Trash and Recycling collection in the Township:

- Trash and recycling must be out the night before your collection day, or prior to 6 AM on the day of collection
- Please bag all trash. Loose trash is a potential health hazard for our employees, is more difficult to collect and is a major factor in municipal litter. If you are placing loose cardboard out for recycling, please flatten all boxes and stack them neatly next to your recycling can.
- Yard Waste will be collected on your regular collection day along with your trash. Please bag all loose yard waste in biodegradable bags and cut and bundle any limbs or branches into bundles four feet long or less.
- Each residence is allowed one bulk item per week (stove, washer or dryer, refrigerator/window AC unit with the freon removed, couch, etc.)
- If you have more than one bulk item, or more than 15 bags of trash, please call Customer Service to schedule a collection. Extra fees may apply.
- There will be 12 Leaf collections throughout the year. They will be advertised when the dates are finalized in the new year.

Billing Information

County Hauling participated in an open and competitive bid process, in which the Township solicited bids from local and national waste haulers. County Hauling was the *lowest responsible bidder* and, as per state law, was awarded the contract. This award was not only based upon providing the lowest bid, but also upon our proven track record of high-quality service across more than eighty thousand residential customers in over 30 municipalities. We will be billing each individual unit in Hempfield, beginning the 1st quarter of 2021, and every quarter thereafter throughout the contract. Information regarding the rates for 2021 is below and will be included with the yearly calendars you will receive in the future. While your rates have gone up, please bear in mind that County Hauling was the *lowest* bidder to participate when the contract was put out to bid. There have been many changes in the waste industry in the last decade, both locally and globally, and the past rates are no longer economically feasible. There will be a 2% increase every year of the contract to account for inflation.

2021 Rate - \$55.50/Quarterly

There is a 2% annual payment discount. The **undiscounted** yearly rate is \$222, if paid in 4 installments of \$55.50. The **discounted** yearly rate, if paid in full in the first quarter of the year, is \$217.56.

SENIOR STICKERS: Must be a senior citizen over the age of 62 to exercise this option. 1 STICKER/BAG - \$3.00 PER STICKER. Minimum purchase of 12 stickers at a time. (Please contact Customer Service to set up this option). Recycling is collected weekly free of charge.

If you receive a bill that has the incorrect name, or is addressed to Current Resident, please login through the portal on our website using the information on the bill and request an account update. Our system is based on the address, not the name however, so you can still pay the bill if it is sent to Current Resident or the previous owner, and the payment will be applied to your residence. We will update your information for the next billing cycle upon receipt of an account update request. Please do not attempt to login to the portal before you receive your bill, your account will not be activated until you are billed. If you have any questions about the list of recyclable and non-recyclable materials below, please call Customer Service.

Types 3-7 Plastics are no longer recyclable. There is no market for this material, so if it is put into the recycling, it will be trucked to the recycling plant, then sorted and trucked to the landfill. The best way to reduce the carbon footprint of each item is to follow these guidelines closely and be sure to reach out to our Customer Service if you have any questions!

The two types of plastic that are still recyclable are **Types 1 & 2**, which are among the most common. Examples of Type 1 are soda, water, salad dressing and cooking oil bottles (bottles you drink from or that hold consumables). Some examples of Type 2 are milk and juice jugs, shampoo, conditioner or bodywash bottles and laundry detergents containers. Neither of these lists are comprehensive, so be sure to check each container for the recycling logo and the codes PET or PETE for Type 1 and PEHD or HDPE for Type 2. If the container has any of these codes, it is recyclable. If it does not, then it is not recyclable.
