

HTAC Membership Policy



The Hempfield Township Athletic Complex Membership Policy was put into effect on February 1, 2013 and updated January 1, 2017 by the Hempfield Township Parks & Recreation Department. Individuals must obtain a membership card to enter the gymnasium and participate in any walk-in activity – including Walking, Open Court, Fitness Classes, and Adult Pick-up Sports. All walk-in activities have an associated fee for each admittance except for general walking. Open Court and Adult Pick-up Sports is \$3.00 for each admittance. Fitness Classes are determined per class. Membership cards are not needed for rentals, spectators at a league game, or participants in youth sports or programs.

Membership Card Fees:

The fee is an annual fee and must be paid in full when receiving the card. Cards will not be issued without payment and a signed form by a parent/guardian for those under 18 years old.

Non-Residents (Ages 14 – 64)	\$10.00 annual fee
Non Residents (Ages 65 & older)	\$5.00 annual fee
Replacement Card (Resident or Non Resident)	\$5.00

Membership Card Age Breakdown:

The following describes the individual requirements for each age group for Walk-in Activities

- **0 years old – 3 years old:**
 - No membership card is required.
 - Must be accompanied by a responsible adult with a Membership Card – No drop-offs are allowed.
 - No payment is required for this age group for any walk-in activity.
- **4 years old – 13 years old:**
 - No membership card is required.
 - Must be accompanied by a responsible adult with a Membership Card – No drop-offs are allowed.
 - Payment is required for this age group for walk-in activities. See above.
- **14 years old – 17 years old:**
 - Must have own individual membership card. Card must be on an account with a parent/guardian. The parent/guardian is not required to obtain a card
 - A parent/guardian must be present at sign-up or must have the parent/guardian's signature on the sign-up form.
 - If parent/guardian or signed form is not present, a card will be made and kept on file. The member will receive card when he or she enters the building again with completed form. If a card is on file and a completed form is not returned the second time, no access will be granted.
 - For Open Courts -- If the parent is not participating with child, the child's card only needs to be presented and payment is required. If parent is participating, both cards need to be presents and payment is required for both.
 - Payment is required for this age group for walk-in activities. See above.
- **18 years and older:**
 - Must have a membership card present at all times.
 - Will not be allowed to enter the building without their membership card.
 - Payment is required for this age group for walk-in activities. See above.
- **Special Needs Agencies:**
 - The agency must have a membership card.
 - If the agency is located outside of Hempfield Township, the one-time fee must be accessed.
 - The card must be presented upon entrance.

If the patron does not have the money to purchase a membership at time of entrance, no admittance to the building will be permitted.
